ALL entries will be recognized by the Tuolumne County Friday Night Live Partnership.

ARTIST REQUIREMENTS

- All artists must live and attend elementary school or high school in Tuolumne County in the 2023-2024 school year (early graduates in this school year are welcome).
- All artists must be 18 years of age or younger.
- Artists in 1st 3rd grade must have a guardian's signature.*
- Artwork must stay on display during the entire show time on campus (if applicable) and at the Sonora Chamber of Commerce.
- All artwork must be accompanied by a signed release and registration form. Each person may submit one
 (1) piece of artwork.

ART REQUIREMENTS

- Show is open to the following artistic mediums: painting, sketch, mixed media, graphic design, photography, and poetry
- REMINDER: Art will have viewers of all ages and must adhere to school code or policies.
- NO NAMES DIRECTLY ON ARTWORK. All identifying information name, grade, school must be included with submission, but not incorporated into the artwork.
- Brand names and copyrighted images or materials (i.e. characters from cartoons or TV, brand logos, or printed literature) will be disqualified.
- Only one (1) entry per student may be submitted.
- Each work must be clearly labeled on the back with the artist's name & title of work.
- Please submit works in an organized fashion and make sure their label matches the information provided on the registration form.

Entrants will be contacted if their work is selected to be shown at the Sonora Chamber of Commerce through the month of March 2024 by the Friday Night Live Youth Development Coordinators using registration information provided.
